

## Stamford Easter Revision Courses Terms & Conditions

### General

1. Places on each course are allocated on a first come, first served basis and are not guaranteed until paid for in full.
2. Late applications will only be considered if there are unfilled places on the course.
3. Stamford Endowed Schools (SES) reserve the right to cancel a course if numbers enrolled do not reach the minimum required.
4. SES reserves the right to change advertised tutors or coaches, or to amend the programme where it is found to be unavoidable or in the best interest of participants.
5. SES reserves the right to request the withdrawal of a student for any behaviour which might be considered detrimental to the smooth running of the course, or which might interfere with the studies of other students. Any refund of fees will be at the sole discretion of the Course Director.
6. We will endeavour to communicate the course timetable to all parents and students at least two weeks prior to the start of the courses.
7. We will make every effort to match tuition with individual needs, but students must realise that a revision course, however intensive, cannot be expected to cover all aspects of all specifications. Some courses are not designed to be board-specific; these courses aim to cover core material only for that subject.
8. Drugs and alcoholic beverages may not be brought onto or consumed within the boarding houses or any other part of the Stamford Endowed Schools campus. Failure to abide by this rule will result in immediate withdrawal.
9. Stamford Endowed Schools has a no smoking policy throughout all buildings and grounds.
10. Any student who needs to leave the Stamford Endowed Schools campus at any time for any reason during the course must obtain permission from the Course Director.

### Payment and Cancellation

1. Payment is required in full at the time of booking.
2. If for any reason SES cancels a course, you will be offered either an alternative course, or a full refund.
3. If you need to cancel a course for any reason, we will offer you a refund of 50% of the fee.

### Liability

1. Parents or guardians will accept full liability for any damage to property caused by malice or neglect.
2. SES shall not be liable for loss or damage to personal property or injury to persons however caused, other than that where negligence on the part of Stamford Endowed Schools is proven.
